1. Existing Manufacturing Plant License Fee: **\$100.00**; in addition:

A. **\$5.00** for each 1,400,000 pounds of milk or fraction thereof purchased during previous 12 month period ending June 30 (Example: 2,800,000 pounds of milk purchased ÷ 1,400,000 x \$5.00 = \$10.00).

2. **\$100.00** for any dairy products manufactured or processed and not included in 1A above and based on 100,000 pounds or less of volume production, herein to be considered the equivalent of 1,000,000 pounds of milk or fraction thereof; and **\$5.00** for each additional 1,400,000 of milk or fraction thereof. (Frozen desserts, Grade A products and products manufactured or processed under contract for the Commodity Credit Corporation are exempt.
